Midway Shelter Leads Alameda County

In spite of another year of financial uncertainty and growing need in our community, we received news this summer that buoyed our spirits and reinforced our commitment to ending homelessness.

our emergency site in Alameda, achieved the best permanent housing placement rate of all the shelters in Alameda County! **San Leandro Shelter** ranked in the top five. Even better, 75% of those exits to housing occurred within 60 days.

Bessie Coleman Court, Building Futures' supportive housing site at Alameda Point, also achieved high rates for transitionally housed residents leaving us for permanent housing, and permanently housed residents maintaining their housing.

“I deserve something better...”

Tia Jennings, Building Futures' outreach coordinator, frequently works with survivors of domestic violence in our community support and education groups.

Once someone leaves a class or group though, she often loses touch with them, never knowing where their lives take them afterwards.

Recently, Tia stopped in at a small diner to pick up lunch on her way back to the office. The woman behind the counter looked familiar. She told Tia she

had taken one of her classes. Tia greeted her, ordered her food, and left while it was prepared.

When she returned, the woman said, “You know, I got a lot out of your class, Tia. I left him.” She proceeded to tell Tia how, like so many other domestic violence survivors, she thought he would change, but he didn't. Thanks to the lessons she learned in our classes, she realized she couldn't remain in that cycle anymore. She said one day she dropped

him off at his home and never went back.

“He still calls,” she said, “but I deserve something better.”

Serving Those Who Have Served

In October, the Department of Veterans Affairs awarded the Alameda County Coalition for Veteran Families a \$1 million grant to help homeless and at-risk Veteran families find and keep housing.

This new program is part of the VA's focus on providing employment, permanent housing, and aid to Veterans and their families at risk of becoming homeless.

Due to the expertise we developed in homelessness prevention and rapid re-housing

as the lead agency for the Mid-County Housing Resource Center, Building Futures was invited to join the coalition.

We will provide housing assistance and case management to Veterans' families.

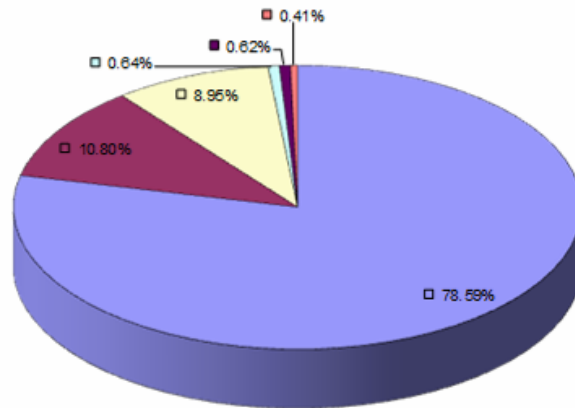
Today, eight women meet at members’ homes each month, to pray together, and share what is happening in their lives.

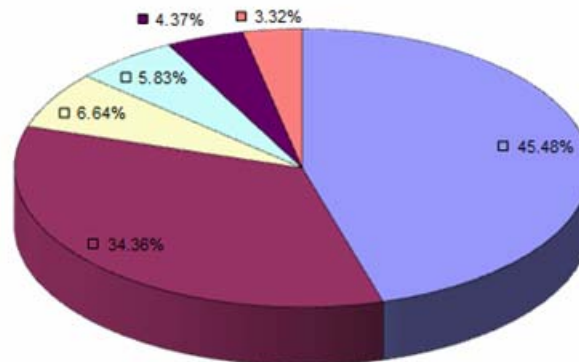
